| 2. | Authority<br>Title 22<br>Sec. 14.122<br>34 CFR<br>Sec. 300.226   | The Board shall adopt a system of screening that may include early intervening<br>services and must be designed to accomplish identification and initial screening<br>for students prior to district referral for a special education evaluation. The<br>system shall provide support to staff to improve working effectively with<br>students in the general education curriculum, identify students who may<br>require special education services and programs, and must include hearing and<br>vision screening and screening at reasonable intervals to determine whether<br>students are performing at grade appropriate levels in core academic subjects. |
|    | 34 CFR<br>Sec. 300.226   | Early intervening services shall comply with the requirements of state and<br>federal law and regulations in order to address academic concerns or behaviors<br>that may be impeding success, but which can be resolved through research-<br>based intervention programs in the regular education setting.  |

| Title 22<br>Sec. 14.124<br>34 CFR<br>Sec. 300.302 | Reevaluations shall be conducted within the timeframes required by state and federal laws and regulations unless the parent/guardian and the district agree in writing that a reevaluation is unnecessary. The group of qualified professionals that reviews the evaluation materials to determine whether the child is a student with a disability shall include a certified school psychologist when evaluating a student for autism, emotional disturbance, mental retardation, multiple disabilities, other health impairment, specific learning disability and traumatic brain injury.   |
|   | Copies of the reevaluation report shall be disseminated to parents/guardians at least ten (10) days prior to the meeting of the IEP team unless this requirement is waived in writing.  |
|   | Independent Educational Evaluations   |
| 34 CFR<br>Sec. 300.502                            | A parent/guardian who disagrees with the results or content of an evaluation<br>performed or obtained by the district may request an independent educational<br>evaluation at district expense. A parent/guardian is entitled to only one (1)<br>independent educational evaluation at public expense each time the district<br>conducts an evaluation with which the parent/guardian disagrees. The<br>independent educational evaluation must arise from parents'/guardians'<br>disagreement with the district's most recent evaluations or reevaluations of the<br>student. The district shall be entitled to a copy of all results of independent<br>educational evaluation is made to a professional employee or<br>administrator, that person shall inform the parent/guardian that the request<br>must be in writing. If the native language of the parent/guardian is other than<br>English, the requirement that the parent/guardian make his/her request in<br>writing shall be conveyed by whatever means practicable and, where feasible,<br>in the native language of the parent/guardian. |
|   | A written request for an independent educational evaluation at district expense<br>shall be immediately forwarded to Coordinator of Special Education, who may,<br>upon receipt of the written parent/guardian request, ask that the<br>parent/guardian state his/her reasons for disagreement with the evaluation<br>conducted or proposed by the district. The district cannot require the  |

| parent/guardian to do so, and the refusal of the parent/guardian shall not delay<br>the process required by this policy.  |
| The criteria under which the independent educational evaluation at public<br>expense is obtained must be the same as the criteria used by the district in<br>conducting an appropriate evaluation, including the location of the evaluation<br>and the qualifications of the examiner, to the extent those criteria are consistent<br>with the  |
| parent's/guardian's right to an independent educational evaluation at public<br>expense. The qualified examiners who conduct the independent educational<br>evaluation may not be employed by the public agency responsible for the<br>education of the student.  |
| Within ten (10) school days of receipt of a request for an independent<br>educational evaluation in writing from a parent/guardian, the Coordinator of<br>Special Education shall either initiate a due process hearing to show that the<br>district's evaluation is appropriate and notify the parent/guardian in writing<br>that s/he has done so or issue to the parent/guardian correspondence<br>containing: |
| 1. Assurance that the district will pay for an independent educational evaluation as long as the evaluation meets all of the requirements of an appropriate evaluation and is in compliance with this policy.   |
| 2. Statement that the district will not pay for the evaluation until it receives directly from the evaluator a complete copy of a report of that evaluation and determines that the evaluation is in compliance with this policy.   |
| 3. Request that the parents/guardians consider accessing reimbursement for all or part of the evaluation from public or private sources of insurance or reimbursement, together with a clear assurance that the parent/guardian is not required to do so and that the district will pay any cost not covered by such sources.   |
| 4. Directions that the parent/guardian is responsible for arranging for the evaluation and ensuring that the evaluator contacts the Coordinator of Special Education to arrange for payment of the evaluation.  |
| Upon request, the district shall provide to parents/guardians information about where an independent educational evaluation may be obtained.  |
| If the evaluation has already been conducted and paid for, the district shall issue correspondence advising the parent/guardian that the district will not  |

| reimburse the parent/guardian for the evaluation until it receives a complete<br>and unredacted copy of the report of the evaluation and determines that the<br>evaluation is in compliance with this policy. The district shall require<br>documentation substantiating that the parents/guardians paid for or incurred<br>the obligation to pay for the evaluation without reimbursement from a public<br>or private source of insurance or reimbursement.<br>The Coordinator of Special Education shall send the correspondence to the |

| parent/guardian by certified mail or by other independently verifiable means of<br>conveyance and enclose a copy of this policy.  |
| The Coordinator of Special Education shall maintain a list of qualified<br>independent evaluators in each of the various disciplines commonly relied upon<br>to provide education-related evaluations and assessments and shall promptly<br>make that list available to any parent/guardian who requests it.  |
